3.1 FINDINGS AND RECOMMENDATIONS OF EXTERNAL VALIDATION PANEL

3.2 Main Findings

The External Validation Panel of Assessors recommends approval of the following programmes: Bachelor of Science (Honours) in Quality and Lean Management with the following exit awards: Bachelor of Science in Science in Quality and Lean Management, Higher Certificate in Science in Operations, Quality and Lean Management and Certificate in Operations Quality and Lean Management.

3.4 Recommendations

- Modify the entry requirement for the Ab-initio BSc Honours programme on page 6
 of the document.
- 2. Check the alignment of the learning outcomes, the use of appropriate verbs to ensure consistency with the programme level.
- 3. Make more explicit the development of soft skills in the programmes, the programme module learning outcomes and indicative content (e.g., Lean Management; Organisational Behaviour and Change Management).
- 4. Establish alternative learning paths for course (e.g., Warehouse Operators, Product Builders, etc).
- 5. Consider changing the module title Quality and Environmental Sustainable Governance to Environmental Sustainable Governance (ESG). Modify the aims

- and objectives of the module to make reference to all management. Use the acronym ESG throughout the indicative content.
- 6. Change references of exit awards to embedded awards where appropriate.
- 7. Differentiate between pre-approved and new modules in the documentation.
- 8. Review the module content and alignment as outlined in the panel discussions as outlined in Section 4.0.
- 9. Consider ways to enhance the development of communities of practice of learners.
- 10. Proofread the documentation to ensure the programme titles are correct in all instances.
- 11. Review module texts and reading lists to ensure they are up to date.
- 12. Move statistical learning from Lean Management to Mathematics and Statistics modules.
- 13. Include treatment of incident management in the Risk Management module (e.g., Social Media).

3.3 Commendations and Observations

- 1. The panel commends the quality of the programme submission and documentation and noted its comprehensive and detailed nature.
- 2. The panel commends the positive and collegiate engagement of the programme team during the validation visit.
- 3. The panel commends the use of broad career pathways outlined in the course offerings.
- 4. The panel commends the programme team on their innovation in programme delivery assessment and links to e-working hubs.
- 5. The panel welcomes the provision of programmes in Lean and Quality that enable professional qualifications.
